# PIRATE FEST TERMS & CONDITIONS 2018

## Terms and Conditions for ALL Vendors

1. Vendor shall submit the required fees in full by 3/30/18 or their vending space and deposit may be forfeited.
2. Vendor is required to be open on stated dates of operation for the duration of the event.
3. Set up begins Thursday: 8am to 10pm Fri. morning vehicles must be OUT OF PARK BY 9am.
4. Operational Hours: Fri. 12pm to 10pm, Sat. 10am to 10pm, Sun. 10am to 8pm. (subject to change)
5. **ALL VEHICLES MUST BE ACCOMPANIED BY PIRATE FEST ON PARK GROUNDS FOR SET UP.**
6. **NO VEHICLES ON THE PARK GROUNDS FRI. SAT. SUN. PRIOR TO OPENING.**
7. **ALL VENDOR VEHICLES MUST PARK IN DESIGNATED AREAS ONLY!!**
8. Vendor must post prices in a legible and visible manner. Vendor will only be allowed to sell items that have been approved in writing by Pirate Fest.
9. **INSURANCE: YOU MUST BE COVERED.** Vendor will provide public liability and property damage insurance in the amount of no less than One Million Dollars per occurrence, Two Million dollars aggregate. Naming: **Pirate Fest, its representatives, agents, volunteers and/or sponsors 1817 Hermitage Dr. Las Vegas, NV 89108 and The City of North Las Vegas, its Elected Officials, Agents, Employees and Volunteers c/o Risk Management and Purchasing 2250 Las Vegas Blvd., North, Ste. 700 North Las Vegas, NV 89030** as also insured. Pirate Fest must receive the certificate no later than April 11, 2018 (Certificate can be emailed). Vendor is solely responsible for all personal property at all times.
10. **FIRE INSPECTION:** Vendors will be required to have on site a fire extinguisher with a minimum rating of 2A10B:C and a licensed NV fire protection company must have serviced it within one year. IF you do not have a certified extinguisher you may rent one for the duration of the event for \$10.00. A separate \$50.00 deposit check is required, returned if extinguisher is returned in good working condition and not activated. Any frying equipment including commercial grade deep fryers, woks, pots, etc. will require a K class, NV certified, extinguisher. No K Class extinguishers are available for rent.
11. **SUBLEASING:** Vendor may NOT sublease or share their space unless prearranged with Pirate Fest in advance. Sublease in this context includes but is not limited to: renting, sharing donating or in any way allowing another company or person to display or advertise in a vendor's space.
12. **INDEMNIFICATION:** Vendor agrees, by accepting this agreement, regardless of coverage under any insurance policy, to pay all costs necessary to indemnify, defend and hold Pirate Fest, its sponsors and/or promoters harmless from all claims, demands, losses actions attorney's fees, cost and expense based on or arising out of any acts, errors, omissions fault, or negligence of contractor or its principals, employees, subcontractors or other agents while performing services under this contract.
13. **HEALTH PERMIT:** Food Vendors must obtain a temporary food permit from the Health Authority. These permits must be available on site. You will not be able to open if you do not have a health permit.
14. **SALES TAX:** Vendors are responsible for keeping track of all of their sales and paying current applicable Nevada State Sales Tax at the end of the festival. If you are forced to close by any government agency for failure to obtain any necessary permit and/or license, Pirate Fest is not liable and will not refund any fees. Any questions should be directed to **Nevada Department of Taxation** at 702-486-2300. Nevada law requires that all vendors must pay sales tax on all goods sold in Nevada.
15. **SECURITY:** Security is provided (as a courtesy) for the vendor's booth area from 9pm Friday April 21 to 8am Monday April 24, 2017. Vendor can stay overnight to provide security within their respective booth space. Pirate Fest and Security company/persons will not be held liable or responsible for any loss, theft or damage.
16. All business activity must be conducted in the designated booth space. ***No distribution, canvassing, flyers or vending outside of the booth space, or loud announcements either vocally or through amplified means.***
17. No animals allowed unless preapproved by Pirate Fest. Certified service animals are exempt.
18. All tents larger than 20x20 must have a certificate of fireproofing certificate.
19. **NO OVERNIGHT POWER WILL BE PROVIDED.** Any overnight power is the responsibility of vendor with prior approval of Pirate Fest.
20. All weapons must be sheathed and peace tied at all times. Any person found brandishing a weapon outside of a scheduled performance may be subject to immediate expulsion from the festival.
21. Staking of tents: only stakes less than 10 inches. A Pirate Fest official must be present when staking.
22. Vendors must be off the park property by Monday April 23, 2018, 8pm.
